- to Join the M.Phil/Ph.D. programme within 30 days from the date of issuance of this letter;
- to Produce an affidavit duly sworn in before a 1st Class Magistrate to the effect that he/she is not working anywhere at present;
- the In-service candidates shall be required to produce the leave sanction and relieving order from their parent Department.

IV. Part-time Scholars

The candidate(s) registered on part-time basis may not be allowed to join unless he/she/they produce/s the following documents: -

- No Objection Certificate from his/her employer for joining the Research Programme;
- Reserved Quota Certificate as per rules from the concerned Head of the Department;
- Certificate of having rendered substantive service for the period as provided under statutes 7 & 29 from the employer;
- 4. Leave sanction and relieving order for the residency period of 120 days to be completed in one spell in case of M. Phil; and
- 5. The residency period of 210 days to be completed in two spells of 90 days in case of Ph. D. scholars and it shall be mandatory for the scholars to put in the residency period when the session is on.
