

7. Any equipment procured under the said project shall be allowed to be used by any other research agency as and when needed;
8. Stock Register for any purchase made under the project should be properly maintained for audit purposes or as and when needed;
9. Physical and financial progress of the projects should be communicated after every three months, or whenever asked for;


