I am pleased to inform you that based on your qualifying for Eligibility for Assistant Professor in the Joint CSIR-UGC Test conducted in December 2019, you have been selected for award of fellowship under the scheme of **Maulana Azad National Fellowship for Minority Students - 2019-20**.

The tenure of the Fellowship is five years and it commences from the date of declaration of result of Joint CSIR-UGC Test, viz., **23.01.2020** (or) from the date of admission under M.Phil/Ph.D (or) from the date of joining M.Phil/Ph.D programme, whichever is later.

As you had taken admission for M.Phil/Ph.D through regular and full time mode in a UGC recognized University / Institution while applying for Joint CSIR-UGC Test, you are required to apply for fellowship not later than three months from the date of issue of this award letter. The University/Institution is requested to process for award of fellowship based upon this letter, in accordance with the Guidelines of scheme and Notification dated **31.07.2020**. It may be noted that the fellowship amount shall be disbursed through Canara Bank to bank account of the awardee (any bank) directly. UGC has developed a dedicated web portal (https://scholarship.canarabank.in) for capturing data of the awardee. The Universities/Institutions will link the data of the awardee with the master data on the UGC web portal with unique Maker and Checker IDs which have already been provided to them along with the passwords. The Universities/Institutions shall update the information on the master data (regarding monthly payment confirmation, HRA, up-gradation, resignation etc.) of the beneficiaries on monthly basis. Based on the data updated on UGC web portal by the concerned Universities/Institutions, the payment of the fellowship will be made to the beneficiaries (Detailed process is available at https://www.ugc.ac.in/ugc_notices.aspx?id=2153).

The e-Certificate of Eligibility for Assistant Professor has already been uploaded on https://ecertificate.nta.ac.in/. The eligibility of the candidate for availing the fellowship is to be ensured by the University/Institution.
